

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to 2605 NE 130th Ct. and TRI-180 Coaching and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to TRI-180 Coaching include 2605 NE 130th Ct. and info.tri180coaching.com. The TRI-180 Coaching website is a Professional Service and Coaching site. By using the TRI-180 Coaching website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, TRI-180 Coaching may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address

If you purchase TRI-180 Coaching's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

TRI-180 Coaching may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender

We do not collect any personal information about you unless you voluntarily provide it to us. Use of your Personal Information

Sharing Information with Third Parties

TRI-180 Coaching does not sell, rent or lease its customer lists to third parties.

TRI-180 Coaching may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to TRI-180 Coaching, and they are required to maintain the confidentiality of your information.

Tracking User Behavior

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by TRI-180 Coaching. Use of Cookies
